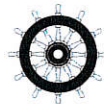

## Product description

"BrannX P" made of plywood plate from poplar. The plates are impregnated with "FirePro (DFP)" impregnation agent. Minimum wet agent concentration is 15%.

Thickness: 4-28 mm  
Specific weight: 2-15 kg/m<sup>2</sup>  
Density: 380-550 kg/m<sup>3</sup>

"BrannX P" is manufactured by Woodsafe Timber Protection AB, Sweden and by Fritzøe, Åndalsnes, Norway.

## Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use on any non-combustible substrate.

The product satisfies the requirement for maximum calorific value (ref. Solas Chapter II-2, Reg 5.3.2.2) without further testing.

Any adhesive used has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Each product is to be supplied with its manual for application and maintenance.

Test Report No. 4P04767 dated 2015-02-25 from SP Technical Research Institute of Sweden, Borås, Sweden (note that the product names in the test reports deviates from the product names in this certificate).

## Tests carried out

Tested according to IMO 2010 FTP Code part 5 and Annex 2 Item 2.2 and 2.3.

## Marking of product

The product or packing is to be marked with name of manufacturer, type designation, MED Mark of Conformity and USCG Approval Number if applicable (see below).

## Mark of Conformity

The manufacturer is allowed to affix the Mark of Conformity according to Article 11 in the Council Directive 96/98/EC on Marine Equipment and shall issue a Declaration of Conformity, only when the module D or E or F of Annex B in the same directive is fully complied with.

Module D: The quality system for production and testing shall be approved by the Notified Body.

Module E: The quality system for inspection and testing shall be approved by the Notified Body.

Module F: Compliance of the products to type as described in this EC Type-Examination Certificate must be verified by the Notified Body who also shall issue a Certificate of Conformity.

## USCG Approval

A U.S. Coast Guard approval number will be assigned to the equipment when the production module has been completed and will appear on the production module certificate (module D, E or F), as allowed by the "Agreement between the United States of America and the EEA EFTA states on the mutual recognition of Certificates of Conformity for Marine Equipment" signed 17 October 2005.
